The managing director has the responsibility and authority for examining whether the proposed exclusions are conducted within the framework of management reviews of the quality system.

(b) JUSTIFICATION

4. RISK ASSESSMENT POLICY

IKAP INVESTMENTS LIMITED understand the importance of the risk assessment policy as regards the working environment. We face and deal with risks everyday, most of the time we assess and manage risks without making a formal written assessment. At work we are able to manage the risks ourselves without having to refer to the others in the organisation.

However, there are some risks which are beyond our ability to fully understand or control. These risks need formal risk assessment after which some can be controlled and managed by the individual or local team, however others may need to be referred to, senior staff in the organisation.

> DEFINITIONS

The following definitions are used to assist those involved in risk assessment :-

1. Hazard

A hazard is something which has the potential to cause, injury, illness or harm, for example.

- Cylindrical drums are hazardous substances as they can cause burns to the skin and injure the lungs if inhaled.
- Sharps, such as syringes, have the potential to transmit infection if they puncture the skin after being injected into another person.

2. RISK

Risk is the likelihood that a hazard will have on adverse out come with a consideration of how bad the outcome is likely to be

An example is:-

- As sharp object disposed on the floor in a clinic presents a high risk of injury of especially to inquisitives children.
- As sharp object correctly placed in bins which are out of reach normally pose a low risk of injury to children. Risk assessment is a careful examination of what, in your work practice and area, could cause harm so that you can weigh up whether you have taken enough precautions or should do more.

To implement this pony we

- Ensure that the working environment is condusive for personnel and clients.
- Provide risk assessment training to the staff.
- Communicate the findings of assessments staff.
- Inform managers when assessments need reviewing.

- Co-operating with the implementation of this policy.
- Reporting to managers any assessments which appear to need reviewing.
